Warranty Policy (Effective 01-01-2020)

Patton Divider Block Systems warrants its products to be free from defects in material and workmanship on the date of sale by Patton Divider Block Systems, or its duly authorized distributor, to the original purchaser of components. This warranty cannot be transferred or assigned by the original purchaser. With the exception of any additional extended, or limited warranty published by Patton Divider Block Systems, the components will, for a period of Twenty Four (24) months from the date of sale, replace any product determined by Patton Divider Block Systems to be defective. This warranty applies only when the products are installed, operated and maintained in accordance with Patton Divider Block Systems' written recommendations described in "Patton's Operation and Maintenance of Divider Block Systems Training Manual" or as listed under **Extended Warranty** below.

THIS WARRANTY DOES NOT COVER, AND PATTON DIVIDER BLOCK SYSTEMS SHALL NOT BE LIABLE FOR; GENERAL WEAR AND TEAR OR DAMAGE CAUSED BY THE FOLLOWING: ABUSE, FAULTY INSTALLATION BY ANY THIRD PARTY, MISAPPLICATION, CORROSION, INADEQUATE OR IMPROPER MAINTENANCE, NEGLIGENCE, ACCIDENT, TAMPERING, SUBSTITUTION OF NON-PATTON DIVIDER BLOCK SYSTEM COMPONENTS OR INCOMPATIBILITY OF PATTON DIVIDER BLOCK SYSTEMS COMPONENTS WITH EQUIPMENT, ACCESSORIES OR MATERIALS NOT SUPPLIED BY PATTON DIVIDER BLOCK SYSTEMS, OR THE IMPROPER DESIGN, MANUFACTURE, INSTALLATION OR MAINTENANCE OF SAME.

This warranty is conditioned upon the prepaid return of product claimed to be defective to Patton Divider Block Systems. If the claimed defect is verified, Patton Divider Block Systems will repair or replace free of charge any defective parts. The repaired or replacement parts will be returned to the original purchaser freight prepaid. If Patton Divider Block Systems inspection fails to verify the claimed defect in material or workmanship, repairs or replacement will be made at the expense of the original purchaser.

Patton Divider Block Systems' sole obligation and the original purchaser's sole remedy for any breach of warranty shall be as set in this Warranty Policy. The original purchaser agrees that no other remedy (including, but not limited to, incidental, consequential, direct, indirect or special damages for lost profits, lost sales, injury to person or property, or any other incidental or consequential loss) shall be available. Any action for breach of warranty must be brought within two (2) years of the date of sale to the original purchaser.

The items sold but not manufactured by Patton Divider Block Systems are subject to the warranty, of their manufacturer. Patton Divider Block Systems will provide purchaser with reasonable assistance in making any claim for breach of these warranties. In no event will Patton Divider Block Systems be liable for indirect, incidental, special or consequential damages resulting from Patton Divider Block Systems supplying products hereunder, or the furnishing, performance, or use of any products or goods sold hereto, whether in contract, warranty, tort, negligence, strict liability or otherwise. This warranty is governed by Texas law.

LIMITED WARRANTIES

Patton Divider Block Systems offers a limited warranty for leaks arising from divider block system installation, which will cover, repaired parts, tubing, tubing fittings and connections. With respect to these products and installation, for a period of thirty (30) days from the date of installation, Patton Divider Block Systems will repair or replace any such labor or products determined by Patton Divider Block Systems to be defective. All other terms and conditions of the Patton Divider Block Systems warranty apply.

EXTENDED WARRANTIES

Patton Divider Block Systems extended warranties, as indicated below, for the following products at no additional cost. All other terms and conditions of the Patton's warranty apply.

Twenty Four (24) Months Warranty Covers All Divider Block Systems and Accessories Purchased From Patton Divider Block Systems: Warranty is Subject to Filter Changes to Both High Pressure and Low Pressure In-Line filter Elements.

EXTENDED WARRANTY: Extended warranty of Twenty Four (24) Months extends the warranty period to 48 months after installation. The EXTENDED WARRANTY, may be purchased at time of purchase or/or installation of the divider block system.

WARRANTY RESPONSE TIME

Warranty response time is quoted on an individual basis for each lubrication system installed, and depends on the location and time needed to arrive on-site. Patton Divider Block Systems will request a telephone conference with the person responsible for the call out to assist the operator in identifying the problem prior to driving to your location. This could possibly help getting the compressor back on-line and alleviate down time and possibly alleviate unnecessary charges for service calls not covered under the warranty. After visiting the site, all issues found that are not covered by warranty will be charged at current Patton Divider Block Systems labor, travel and mileage rates.
